## Fund objective

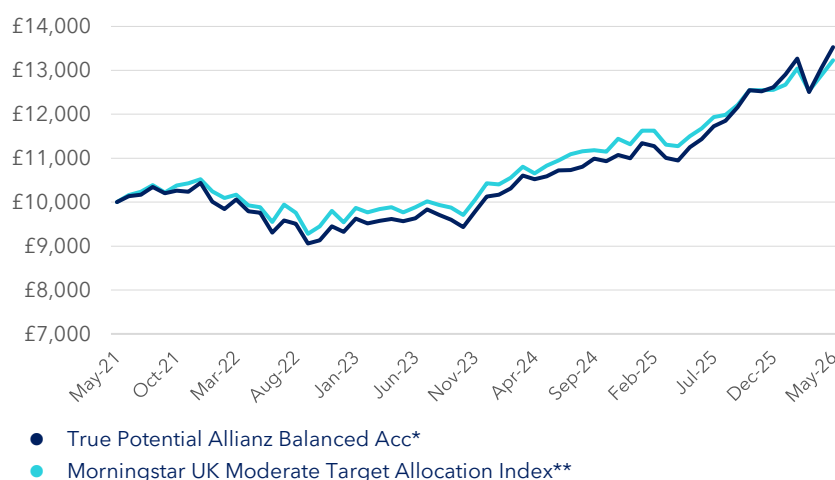
The Fund aims to achieve growth over rolling 5-year periods, net of fees.

## May Update

Global equities rose again in May amid hopes of a de-escalation in the Middle East and rally in artificial-intelligence (AI) names. Emerging Market (EM) equities led the gains and outpaced their developed market counterparts, driven by South Korea and Taiwan. In developed markets, US technology shares outperformed, while UK equities proved a laggard. In fixed income, UK Gilts did well, while US Treasuries underperformed.

The True Potential Allianz Balanced Fund returned 3.75% (net of fees). The Fund's large allocation to equities proved beneficial as the asset class significantly outperformed over the month. The Fund's sizeable exposure to EM shares did particularly well, with a strong performance from the Allianz Emerging Markets Equity Fund. The allocation to Chinese domestic shares via the Allianz China A Shares Fund (hedged to sterling) also did well. Elsewhere within the segment, exposure to Japanese equities was also supportive. Conversely, the exposure to UK equities weighed on returns, as the region notably lagged the broader market. The Fund's structural bias for European shares was also unhelpful. In fixed income, a sizeable exposure to UK Gilts was beneficial. Meanwhile, the allocation to EM debt produced positive returns in absolute terms but lagged UK corporate bonds. In alternatives, the Allianz Dynamic Commodities Fund detracted.

The OCF of this fund is currently 0.76%. This means that if you invest £1000 in the fund, you can expect to pay £7.60 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
