Fund objective

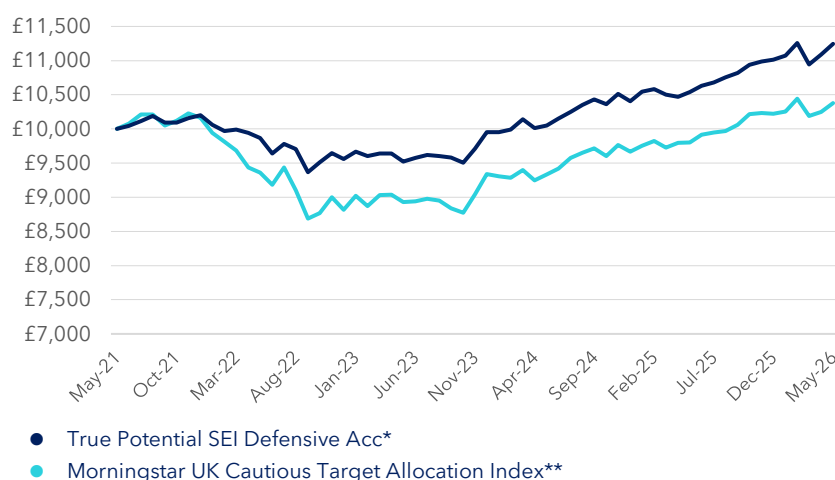
The Fund aims to protect against the risk of a significant loss of capital and to provide some growth and income growth by investing in other investment funds which have an equity and fixed income focus.

May Update

Global equities rose again in May amid hopes of a de-escalation in the Middle East and rally in artificial-intelligence (AI) names. Emerging Market (EM) equities led the gains and outpaced their developed market counterparts, driven by South Korea and Taiwan. In developed markets, US technology shares outperformed, while UK equities proved a laggard. In fixed income, UK Gilts did well, while US Treasuries underperformed.

The True Potential SEI Defensive Fund returned 1.40% (net of fees). The Fund's allocation to equities drove performance as the asset class significantly outperformed over the month. All of the allocations to index funds that track global equity factors produced gains in absolute terms, with the SEI Select Value Fund performing particularly well and outpacing the broader market. The SEI Select Momentum Fund also produced solid gains yet lagged global equities. Conversely, the 'managed volatility' factor proved a laggard over the period as riskier assets outperformed. Elsewhere, the Fund's lack of exposure to EM shares was detrimental over the period. In fixed income, UK Gilts outperformed as yields fell amid lower-than-expected UK inflation. The Fund's sizeable allocation to EM debt also delivered gains and outpaced high-yield bonds. Elsewhere, the exposure to alternatives via the SEI Liquid Alternative Fund was supportive.

What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.87%. This means that if you invest £1000 in the fund, you can expect to pay £8.70 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
